- Vendor set-up is only allowed the **DAY of the EVENT between 6:00 A.M. and 8:00 A.M.**
- **Vendor required to be completely set up prior to 8:00 A.M. on the event day.**
- No early booth tear-downs prior. Vendors are required to be present from the beginning of the show and to exhibit for the duration of the show. At least one person must be in the vendor display area at all times between 8:00 A.M. to 2:00 P.M.
- Vendors agree to keep all vehicles out of the Vendor Display area between 8:00 A.M. to 2:00 P.M., unless vehicle is a food truck or part of vendor product display.
- Non Food Vendors agree not to sell, display or give away beverages or food of any kind.
- Vendors agree not to sell, display, or give away any items containing any part of event title or words Legends of the Highway (excluding official event t-shirt vendor).
- Vendor warrants its products to be of a pleasing and safe nature and its sales are in accordance with the laws of California.
- Vendor agrees not to emit any unduly loud or unreasonable noise in demonstrating its products or for any other purpose.
- Vendors must provide their own displays, chairs, tables, and coverings.
- No vendor electricity is available. If a vendor brings a generator, it must be low noise emitting.
- No Alcoholic Beverages or Illegal Substances Allowed.
- Rain or Shine Event

- In the event that a vendor does not conform to the terms of this contract, Legends of the Highway Staff have the right to remove the vendor from the Car Show Venue. No refunds will be issued if the vendor is asked to leave.
- Vendor gives permission to use any photographs or information obtained prior to and at the event for publication advertising and video filming at the event.
- There is no guarantee of success or failure at this event. The organizers of this event or sponsors are not responsible for losses of any kind suffered by Vendor.
- All vendors must comply with all City, Fire and Health agency requirements.
- All food vendors must have proof of current general Liability Insurance.
- Prepared food must come from a facility inspected by a County Health Department and have a Health Department Permit, and any produce seller must have a CFM certificate from the Orange County Agriculture Department.
